# **Understand Country- Specific Requirements**

Research your chosen destination's unique visa and residency rules. Some countries offer retirement visas, while others favor digital nomads, investors, or those with specific skill sets.

# **Assess Your Eligibility**

Confirm you meet criteria like minimum income requirements, investment thresholds, age restrictions, or professional qualifications. Most countries publish these requirements on official immigration websites.

# Identify Restrictions Upfront

Be aware of limitations or special conditions. Some visas restrict employment, require minimum in-country stays, or have complex renewal processes. Know what you're signing up for.

# **Common Visa Categories for Americans**

- Retirement/Pensioner Visas: Based on guaranteed income from pensions or investments
- **Digital Nomad Visas:** For remote workers employed by companies outside the country
- Investor/Business Visas: Require significant financial investment or business creation
- Skilled Worker Visas: Based on employment offers in specific industries
- Family Reunification: Based on marriage or family ties to citizens


